The Mockingbird Youth Network (MYN) is a powerful, state-wide coalition of young people ages 13-25 who have been impacted foster care and/or homelessness. The program focuses on youth leadership development, civic engagement, system reform, and educating the public of foster care issues. In 2012, more than 427 youth participated in activities such as local chapter meetings, leadership trainings, annual events, and community engagement projects. Six chapters are located in major population centers across the state and each chapter's youth are actively engaged in shaping a reform agenda. Youth regularly meet with policymakers, sit on issue work groups, speak at community forums, and offer creative ideas to improve child welfare systems based on their own experiences.

The Mockingbird Society's Public Policy & Communications program advocates for upstream system reform in collaboration with policymakers, child welfare advocates, service providers, and constituents impacted by the foster care system, including children, youth and families. Over the past 11 years, The Mockingbird Society has helped advance more than 19 major system reforms. Our legacy priority is to ensure that all youth aging out of care have the opportunity to secure safe housing, resulting in reduced homelessness and increased educational and career achievement.

The Mockingbird Family Model (MFM) - a powerful new way of delivering foster care - creates an extended "hub" of family support that improves safety, stability and outcomes for children, youth and families. The MFM has been implemented by agencies in Washington, Kentucky, and the District of Columbia. The Mockingbird Society provides training and technical assistance to help launch MFM sites and continues to advocate for macro replication of the MFM among public and private agencies nationwide. In 2012, the organization advocated to create additional MFM site to benefit children and youth in foster care with behavioral and/or mental health challenges as a strategy to reduce placement disruption and increase child well-being.
