The Mockingbird Youth Network (MYN) is a powerful, state-wide coalition of young people aged 13-25 who have been impacted by foster care. The program focuses on youth leadership development, civic engagement, system reform and educating the public on foster care issues. In 2013, 451 youth participated in activities such as local chapter meetings, leadership trainings and community engagement projects. Six chapters are located in major population centers across the state and each chapter's youth are actively engaged in shaping a reform agenda. Youth meet regularly with policymakers, participate in issue work groups, speak at community forums and offer creative ideas to improve child welfare systems based on their own experiences in foster care.

4b (Code:) (Expenses \$ 183,844. including grants of \$) (Revenue \$)

The Mockingbird Society's Public Policy and Communications program advocates for upstream system reform in collaboration with policymakers, child welfare advocates, service providers and constituents impacted by the foster care system, including children, youth and families. Over the past 12 years, we have helped to advance more than 21 reforms to improve outcomes for approximately 10,000 children in Washington's foster care system, with special emphasis on helping 500 youth who age out of care each year. On behalf of youth who are unstably housed or homeless, our work benefits approximately 27,000 youth in Washington state.

The Mockingbird Family Model (MFM) is an alternative method for delivering foster care. The MFM creates an extended "hub" of family support that improves safety, stability and permanency for children and adolescents in the child welfare system. The MFM has been implemented in Washington, Kentucky and D.C. and we have been contracted by the state of Washington to increase the current HUB sites in Washington by an additional 5 sites by June, 2015.
