

## TRANSPORTATION SUPPORT

### **ISSUE & BACKGROUND**

#### **KEY ISSUE**

The Mockingbird Society's Northern Chapter has identified significant transportation gaps in Northwest Washington, creating challenges for community members in accessing essential services and resources. Limited transportation options impact youth, particularly those from underserved backgrounds, who face difficulties in reaching critical resources like healthcare, education, job opportunities, and social services.



#### CONTEXT

Historical underinvestment in transportation infrastructure has led to significant gaps in service availability, especially in rural areas. These gaps disproportionately affect those seeking homelessness services, foster youth and low-income families, leaving critical needs unmet.

#### **IMPACT**

The lack of reliable transportation hinders the ability of youth to achieve independence and access essential resources, exacerbating social inequities and limiting their future potential.



- **Collaborative Action:** The Mockingbird Society Northern Chapter will collaborate with local government agencies, transit authorities, and private organizations to identify and implement innovative transportation solutions. This may include rideshare partnerships, community shuttle services, and subsidized transit passes.
- **Legislative Pathway:** Instead of legislative changes, this initiative seeks to mobilize resources within the current public-private landscape, leveraging partnerships and existing community programs.

# Social, Economic, or Public Health Benefits:

Increased access to services improves social stability, supports economic mobility, and fosters greater public health outcomes by ensuring critical needs are met.

#### Measurable Results:

Metrics to include the number of youth served, cost savings for families, and feedback on accessibility improvements.



## **TAKE ACTION**

With increasing demands for equitable access to resources, it is essential to act promptly to bridge transportation gaps that inhibit youth from reaching essential services. Our immediate next steps are to engage with identified partners to initiate a pilot program, gather community input to tailor solutions, and secure initial funding from local stakeholders.
